## **CREDIT TERMS**

- 1.** Lion Labels, Inc. sales terms are NET 30 DAYS. A credit limit is normally established within 30 days from receipt of this signed application, based on management's discretion. We accept all major credit cards as form of prepayment, as well as money orders. We reserve the right to apply additional conditions to our afore-mentioned terms (see attached).
- 2.** All payments are to be made payable to **"Lion Labels, Inc."** and submitted to:

- A.** To avoid misunderstandings in account status, an itemized statement of all charges on your account is sent out every month
  - B.** An invoice that is 15 DAYS (45 days) past due will necessitate a hold on further shipments
  - C.** An invoice that is 45 DAYS (75 days) past due will necessitate commencement of collection proceedings
  - D.** A trend of payments over 45 DAYS will necessitate a letter of warning and possibly subsequent termination of open terms. Alternative form of payment in this case will include prepayment with a credit card or money order.
- 3.** Invoice /Statements: The invoice is mailed immediately after shipment. All payments should be made on an invoice basis. Statements provided are to assist you in balancing your payment record.
  - 4.** Returned Checks: A service charge of \$25.00 plus any additional fees charged by the bank will be billed for any checks returned unpaid by the bank for any reason.
  - 5.** Should Applicant default in the payment of outstanding monies due, then Lion Labels, Inc. shall be entitled to incur expenses for the cost of collection, including attorney's fee, which shall be added to the unpaid balance of the Applicants account.
